#### **SYNOPSIS**

The first scientific event of the International Network of Global Studies aims to bring together specialists and researchers from academic institutions around the world who promote teaching and research in the multidisciplinary field of Global Studies. Global Studies seeks to develop scientific knowledge in order to understand the world in the process of globalisation - in its history and in the complexity of its present state - which is characterised by movements of exchange, by interactions between human communities spread all over planet Earth and which have generated and continue to generate interrelationships, interfecundations and metamorphoses on the most diverse levels (cultural, economic, political, religious, social, etc.). This globalising movement, thanks to various forms of mobility (physical and virtual) - facilitated and accelerated recently by the exponential development of information and transport technologies - has led to the emergence of an increasingly acute awareness that human beings are integrated into a world that has a planetary dimension and needs to be better understood if it is understood as being included in a wider totality and sensitive to its interactions and interdependencies, albeit from the perspective of being-locally-in-the-world. This means that understanding the world will always be "glocal", i.e. based on the reality in which human beings were born, formed and

modelled their identity. Basically, the global is a composite reality, integrating the many different places and their interactions.

This first congress has the Amazon as its main theme and scientific pretext, as well as the challenges facing this immense ecosystem today, in terms of the sustainability of planet Earth and within the framework of the desire to promote a globalisation with a human face, eco-sociologically balanced in the harmonious relationship between human beings and the natural environment, of which they are an integral part

The Congress "The World of the Amazon and the Amazon of the World" will address the conservation of Amazonian flora and fauna, highlighting the creation of reserves and the fight against illegal hunting, the diversity of Amazonian ecosystems and their environmental importance, and the impacts of climate change and adaptation strategies. It will discuss the ecosystem benefits of the Amazon, such as climate regulation, and promote sustainable economic models, such as the bioeconomy and ecotourism. It will also examine the health of local populations, the effectiveness of public policies and environmental governance, the causes and solutions to deforestation and reforestation, and the environmental legal framework. It will also explore environmental monitoring technologies and the potential of biotechnology for sustainable development. The Congress aims to promote innovative and sustainable solutions to the challenges facing the Amazon and the planet.
